Main Purpose (Summary)

The Coating Supervisor is responsible for leading daily operations across all timber coating lines at Abodo's Ohinewai site. This role ensures that production runs safely, efficiently, and to the required quality and schedule. The role is also responsible for enforcing safety and 5S standards, and supports continuous improvement of the coating process. The role requires strong leadership, hands-on problem solving, and coordination with planning, despatch, and quality teams to deliver excellent outcomes for customers.

What you will do (Key accountabilities and tasks)

On a day-to-day basis, the role will:

Daily Leadership & Workflow Management

- Supervise day-to-day operation of all coating machines, ensuring timely job starts and shift transitions.
- Allocate and adjust tasks across operators to maintain flow and minimise downtime.
- Escalate equipment, staffing, or material issues to the Manufacturing Manager promptly.
- Conduct daily pre-shift briefings and end-of-day summaries.

Safety & Compliance

- o Enforce all Health and Safety policies, including PPE, manual handling, and safe chemical use.
- Monitor and maintain coating area housekeeping and compliance with 5S standards.
- Conduct safety walks, report hazards, and participate in incident investigations.
- Ensure coating machines have appropriate guarding and operators follow SOPs.

Quality & Process Control

- Ensure all coated products meet surface finish, colour match, and durability standards.
- Work with QA to respond to coating defects or complaints and implement corrective actions.
- Monitor product curing, handling, and packaging to prevent contamination or damage.
- Maintain up-to-date job sheets and records of coating parameters and settings.

People Development & Performance

- Support and coach Coating Machine Operators in daily performance and technical troubleshooting.
- Identify skill gaps and support on-the-job training and cross-training.
- Provide input into performance reviews, development plans, and shift planning.
- Promote a positive and engaged team culture.

Production Coordination & Systems

- Collaborate with the Scheduler and Warehouse team to align coating with upstream machining and downstream despatch.
- Ensure coating runs are prepared in advance, with materials, tools, and labour ready to go
- o Record production outputs, delays, and wastage accurately in the ERP or log sheets
